

Justice Administration Research Association (JARA) is an independent not-for-profit scientific association that aims to develop an international network of academics, policymakers, and professionals working in the justice administration sector.

The Association seeks to promote multidisciplinary research and exchanges of experience in the field of justice administration from a variety of perspectives (institutional, legal, political science, economics, organizational, managerial, etc.) and on a wide range of topics, i.e. judiciary professions, courts' management, rules of procedure, and so on. We aim to function as a platform for the cross-national exchange of information and resources, developing and conducting theoretical, empirical, and comparative studies, promoting education and training programs, and disseminating research results and project evaluations.

## JARA activities include:

- Encouraging and supporting exchanges in webinars, seminars and conferences between researchers and justice administration professionals (judges, public prosecutors, court administrators, experts involved in international cooperation projects, ICT specialists, etc.)
- Exchanging and disseminating information and resources (including studies, research, practices, and innovative policies) relevant to the study of judicial administration.
- Promoting training and education on the administration of justice
- Participating in expert activities in collaboration with international, European, national, or regional institutions in the field of the administration of justice
- Supporting and enhancing research projects and studies in justice administration and related fields
- Developing research and advice with input from academics and practitioners in the justice sector.
